1. The Chairman Department Procurement Committee (DPC) on behalf of the Ceylon Fishery Harbours Corporation invites sealed bids from eligible and qualified bidders for **Proposed Renovation of Existing Auction Hall Building, Net Mending Building & Canteen Building at Ambalangoda Fishery Harbour.**

2. Location of the Project: Ambalangoda, Galle District

3. Description of Project:

The work consists of for **Proposed Renovation of Existing Auction Hall Building, Net Mending Building & Canteen Building at Ambalangoda Fishery Harbour** complete as per the specifications, Drawings and Bill of Quantities given. The Contract Period is ninety (90) calendar days.

4. Bidding will be conducted through National Competitive Bidding Procedure (NCB) with post-qualification criteria given below.

**The Contract will be on Measure and Pay Basis.**

5. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have valid registration in **Grade C6 & C5** in the field of **Building Construction under Construction Industry Development Authority (CIDA) (Former ICTAD)**

6. Qualification requirements to qualify for contract award shall be,

- Value of Construction works performed in last 5 years.
- Value of similar works completed in last 5 years (indicate only the three largest projects.)
- Major items of construction equipment proposed.
- Qualification & experience of key staff-site & Head Office (Permanent, Contract basis & Consultants)
- Other information requested under ITB Clause 4.1

Bids shall be delivered with **Duplicate** addressed to the **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15** on or **before 14.00hrs on 16<sup>th</sup> June 2021.** Late bids will be rejected. Bids will be opened soon after closing in the presence of the representatives of the bidders **who choose to attend**
11. Bids shall be valid up to **31<sup>st</sup> August 2021 ( 77 days).**
12. The Bidder shall seal the Original and the Copy of the bid in two inner separate envelopes and one outer envelope, duly making the inner envelopes as "ORIGINAL" and "COPY".
13. The Original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the bidder with Company Seal.
14. All bids shall be accompanied with a bid security of Rupees one hundred thirty Thousand(**Rs. 130,000.00**) **valid up to 28<sup>th</sup> September 2021**, which shall be in the form included in section 11 – Standard forms (Bid) drawn in favor of **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15.** Bid security shall be obtained from the Commercial Banks operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
