5. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have valid registration in **Grade C9 & C8** in the field of **Building Construction under Construction Industry Development Authority (CIDA) (Former ICTAD)**

Tender Documents relating to above matter can be downloaded from the official web site of the corporation (www.cfhc.gov.lk) The deposit fee should be credited to the corporation's bank account No. **1446** at the Bank of Ceylon, Corporate Branch and the copy of the deposit slip cash payment of Rs. 1,000.00 for the Tender Document set as a Non-Refundable fee.

9. Bids shall be delivered with **Duplicate** addressed to the **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15** on or **before 14.00hrs on 16th June 2021**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the representatives of the bidders **who choose to attend**
10. Bids shall be valid up to **02nd August 2021 (49 days)**.
11. The Bidder shall seal the Original and the Copy of the bid in two inner separate envelopes and one outer envelope, duly making the inner envelopes as “ORIGINAL” and “COPY”.
12. The Original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the bidder with Company Seal.

All bids shall be accompanied with a bid security of Rupees Ten Thousand (**Rs. 10,000.00**) **valid up to 31st August 2021**, which shall be in the form included in section 11 – Standard forms (Bid) drawn in favor of **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15**. Bid security shall be obtained from the Commercial Banks operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
