2. Location of the Project: Hambantota, Hambantota District

3. Description of Project:

The work consists of **Proposed New Toilet Block & Renovation of Existing Toilet Block at Hambantota Fishery Harbour** complete as per the specifications, Drawings and Bill of Quantities given. The Contract Period is One Hundred Twenty (120) calendar days.

4. Bidding will be conducted through National Shopping Procedure with post-qualification criteria given below.

The Contract will be on Measure and Pay Basis.

5. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have valid registration in **Grade C8, C7** in the field of **Building Construction under Construction Industry Development Authority (CIDA) (Former ICTAD)**

6. Qualification requirements to qualify for contract award shall be,

- Information of Work in hand.
- Information regarding Management Staff.
- Information regarding Equipment.

Bid Documents relating to above matter can be downloaded from the official web site of the corporation (www.cfhc.gov.lk) The deposit fee should be credited to the corporation's bank account No. 1446 at the Bank of Ceylon, Corporate Branch and the copy of the deposit slip cash payment of Rs. 1,000.00 for the Tender Document set as an Non-Refundable fee. The Copy of the deposit slip should be attached along with the bid document and if bidder unable to submit deposit slip the bid will be rejected.
10. Bids shall be delivered with **Duplicate** addressed to the **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15** on or before **14.00hrs on 08th November 2021**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the representatives of the bidders **who choose to attend**
11. Bids shall be valid up to **10th January 2022 (63 days)**.
12. The Bidder shall seal the Original and the Copy of the bid in two inner separate envelopes and one outer envelope, duly making the inner envelopes as "ORIGINAL" and "COPY".
13. The Original and the Copy of the bid (Form of Bid) shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the bidder with Company Seal.
14. All bids shall be accompanied with a bid security of Rupees Thirty Thousand (Rs.30,000/-) **valid up to 07th February 2022**, which shall be in the form included in section 11 – Standard forms (Bid) drawn in favor of **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15**. Bid security shall be obtained from the Commercial Banks operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
