Bids shall be delivered with **Duplicate** addressed to the **Manager Procurement, Ceylon Fishery Harbours Corporation, Rock House Lane, Colombo 15** on or before **14.00hrs on 22nd February 2021**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the representatives of the bidders **who choose to attend**.
9. Bids shall be valid up to **22nd June 2021 (49 days)**.

10. The Bidder shall seal the Original and the Copy of the bid in two inner separate envelopes and one outer envelope, duly making the inner envelopes as "ORIGINAL" and "COPY".
11. The Original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the bidder with Company Seal.
