The Bid Security shall be irrevocable and unconditional, and shall be encashable upon the first written request by the Procurement Entity issued by a local commercial bank approved by the Central Bank of Sri Lanka, which is operating in Sri Lanka in favour of **the Chairman, Ceylon Fishery Harbours Corporation, No. 15, Rock house Lane, Colombo 15**. Bid security shall be paid in the form of a cash deposit to the cashier (Sri Lankan Rupees) at the **Head Office or Dikkowita Fishery Harbour (North Terminal)** and the original copy of the cash receipt should be attached with the bid.

Relevant procurement document can be inspected free of charge at the Head Office or Dikkowita Fishery Harbour (North Terminal).

The procurement documents should be submitted in two copies, marked as the original and duplicate, in separate envelopes and then enclosed in a single envelope.

The pre-bid meeting will be held on **09.04.2026 at 10.30 a.m.** at the **Board of Directors' Meeting Room** on the first floor of the head office of the Ceylon Fishery Harbours Corporation.

The procurement document should be duly signed and sealed with the official rubber seal and enclosed in an envelope, with the name of the relevant contract, the closing date and time for receipt of bids written on the left-hand corner and should be sent either by registered post to the address below **on or before 11.00 a.m. on 24.04.2026** or deposited in the tender box kept in the Procurement Division, 2<sup>nd</sup> floor, Head Office, Ceylon Fishery Harbours Corporation.
